RESERVATIONS & DEPOSITS

A 1/3 deposit is required to confirm any reservation.

An additional 1/3 deposit is required March 1st the year of your hunt.

The full balance is due 60 days prior to your arrival in camp. Repeat hunters have a 10% discount. Please indicate the year in which they hunted beside their names.

CANCELLATION POLICY

Cancellation will only be accepted by written notification. Deposits are non-refundable. However, a substitute will be accepted at no additional cost. A reservation is accepted with the condition that the balance is payable 60 days prior to the Client's arrival in camp. Trips that are not fully paid by this date are regarded as being a trip cancellation on the Client's part. One may want to consider purchasing a trip cancellation insurance, available through most travel agencies.

PRICE GUARANTEE

J.H.A. will do everything possible not to increase the price of a booked hunt. However, because some trips are booked two to three years in advance, it is becoming extremely difficult to estimate necessary increases. Should such an increase become necessary, J.H.A. reserves the right to increase the price of any packages. Clients will be advised in writing at least 10 days prior their arrival and if not acceptable, receive a full refund.

FIREARM REGISTRATION

Firearms must be registered upon entering into Canada. There is a \$25.00 CDN fee to be paid to Customs. We will send out the required registration forms upon receipt of your March 1st payment.

RESPONSIBILITY

J.H.A. hunts are strictly **FAIR CHASE**. In the past, they have been very successful and J.H.A. will do everything possible to maintain a high success rate. However, J.H.A. and/or any of its Agents can not be held responsible for any of their Clients failure to harvest game.

J.H.A. will not be held responsible under no circumstances for anything that might happen on any Charter Flights or other form of transportation. Should any Client require a flight into or out of camp for what ever reason other than those scheduled by J.H.A. he will do so at his own cost.

J.H.A. reserves the right to cancel any reservation in full or part that it finds advisable for the comfort or well being of the Clients due to strikes, emergencies, weather or similar situations referred to as acts of God. The Client is entitled to receive a refund on all collected payments up to the value of the cancelled portion of the package and upon receiving such refund the Client shall have no recourse what so ever, directly or indirectly against J.H.A. and /or any of its Agents with respect to the cancellation of the said package.
